## **Identity of the Controller**

## **Purpose and legal basis of the processing**

Your personal data will have processed for the following purposes:

- pre-contractual phase management;
- management and execution of the possible contractual relationship;
- arising from legal obligations, regulations, EU legislation, provisions issued by authorities empowered to do so or by supervisory and control bodies;
- to protect the legitimate interests of **M.P.C. S.R.L. con socio unico** in court or otherwise in accordance with the principles of law.

Such processing will have based on principles of fairness, lawfulness, transparency and necessity in order to protect your privacy and your rights.

The legal basis for the processing of your personal data has constituted by:

- the need to ensure the proper management and execution of the pre-contractual and contractual relationship;
- the need to ensure compliance with obligations under national and Community legislation;
- the need to ensure the protection of the legitimate interest of the holder as indicated above.

The data of natural persons acting in the name and on behalf of the customer and/or in his/her interest, transmitted by the latter, must have considered as collected and processed in accordance with current legislation.

If the Data Controller intends to further process personal data for a purpose other than that for which they were collected, before such further processing, he/she will provide the person concerned with information regarding such other purpose and any further relevant information, asking for his/her consent where necessary.

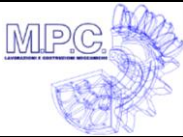
## **Period of data retention**

Your personal data will be stored for the period necessary for the execution of the contract and then for the instead of time required by law, as well as until the limitation period of any reciprocal rights.

The provision of data for marketing and/or advertising purposes is merely optional and subject to the consent of the person concerned: if you do not intend to provide data for such purposes, you will not be informed of the commercial and / or promotional initiatives of the Owner.

## **Nature of the provision of data and consequences in case of refusal**

The provision of data is mandatory in order to fulfill legal and contractual obligations and therefore any refusal to provide them in completely or in part may result in the impossibility for **M.P.C. S.R.L. con socio unico** to execute the contract.

## **Methods of processing**

Your personal data will be processed both with the use of computer tools and manually, with methods and tools designed to ensure maximum security and confidentiality.

## **Categories of addressees**

For the purposes specified above, your personal data will have processed by personnel of **M.P.C. S.R.L. con socio unico**, specially authorized for their respective duties and according to the tasks assigned to them, and communicated:

- to private subjects and/or to investee companies that carry out activities and services on behalf of **M.P.C. S.R.L. con socio unico**, appointed as external data processors according to Art. 28 of the GDPR (such as, by way of example but not limited to: accountant, legal professionals, communications transmission companies, etc.);
- persons performing supervisory functions (e.g. Supervisory Bodies such as Boards and Auditors) or certifying bodies where necessary.

Your personal data as well as those of natural persons who work in the name of and on behalf of the supplier and/or in his/her interest will not have disclosed or automatically processed for profiling purposes.

## **Data transfer to a third country and/or an international organization**

Your personal data will have transferred to third countries outside the European Union.

## **Rights of data subjects**

The data subject has the right to ask **M.P.C. S.R.L. con socio unico**:

- to have access to your personal data and to correct them if they are inaccurate, to delete them or limit their processing if the conditions are met, or to oppose their processing;
- for the portability of data in the cases provided for in the Regulation;
- to revoke consent at any time without prejudice to the lawfulness of the processing carried out before the revocation.

Finally, if the person concerned believes that the processing that concerns him/her violates EU Regulation 2016/679, the latter has the right to lodge a complaint with the Guarantor for the protection of personal data under art. 77 GDPR, or to appeal to the appropriate courts.
